

## Notes on Contributors

**Robert E. Bacharach** has served on the Tenth Circuit Court of Appeals since 2013. He authored *Legal Writing: A Judge's Perspective on the Science and Rhetoric of the Written Word*, published by ABA Book Publishing in 2020. In the book, Judge Bacharach draws on lessons from psycholinguistics and oratory. He has also authored or coauthored articles in the *Indiana Law Review*, *Washington University Law Quarterly*, *Memphis State University Law Review*, *Oklahoma Law Review*, and *Oklahoma City University Law Review*. Before his appointment to the Tenth Circuit Court of Appeals, Judge Bacharach clerked for then-Chief Judge William J. Holloway, Jr. of the Tenth Circuit, worked as a partner at Crowe & Dunlevy law firm, and served as a United States magistrate judge in the Western District of Oklahoma. He is a recipient of the Oklahoma Bar Association's Award of Judicial Excellence.

**Patrick Barry** is a clinical assistant professor and the director of digital academic initiatives at the University of Michigan Law School. He has launched two sets of online series on the educational platform Coursera. The first is based on his book *Good with Words: Writing and Editing*. The second is based on that book's companion text, *Good with Words: Speaking and Presenting*. He is also the author of several other books, including *Notes on Nuance* and *The Syntax of Sports*, and his articles have appeared in *Stanford Law Review Online*, *Georgetown Law Review Online*, the *Journal of Legal Education, Perspectives*, and *Legal Communication & Rhetoric: JALWD*. A frequent collaborator with the University of Michigan Veterans Legal Clinic, he splits his time between Michigan and the University of Chicago Law School, where he has been a visiting lecturer since 2018.

**John G. Browning** is a partner in the Plano, Texas, office of Spencer Fane LLP and a former justice on Texas' Fifth District Court of Appeals in Dallas. He also serves as a visiting associate professor of law at Faulkner University's Thomas Goode Jones School of Law and as the vice president of Scribes. Justice Browning is the author of five law books and more than forty law-review articles. His work has been cited as authority by courts throughout the United States. Justice Browning has received the highest awards for legal writing from the Texas and Oklahoma bars, and he is a four-time recipient of the Burton Award for Distinguished Achievement in Legal Writing.

**Shavonnie Carthens** is an assistant professor of law at the University of Louisville, Louis D. Brandeis School of Law. She teaches Lawyering Skills I, Lawyering Skills II, and Law and Literature. He is also an adjunct professor of legal communication and analysis at the Indiana University Robert H. McKinney School of Law.
